INSTRUCTIONS:

Please complete both sides of application

- No horse, purebred or crossbred, born 1998 or thereafter will be REGISTERED with the USLR unless DNA typed .
- The horse being registered may be blood typed *and* DNA typed for \$67. This may be needed in the case that one or more parent was only blood typed, is now deceased, and the sample at UC Davis has been discarded (only horses sampled in 1988 were discarded).
- RECORDED crossbreds are not required to be DNA typed. RECORDED crossbred Lipizzans are not eligible for USLR Awards.
- RIGHT OF REFUSAL: The USLR reserves the right to refuse registration of a horse based on the governing Rules and Regulations of Registration.

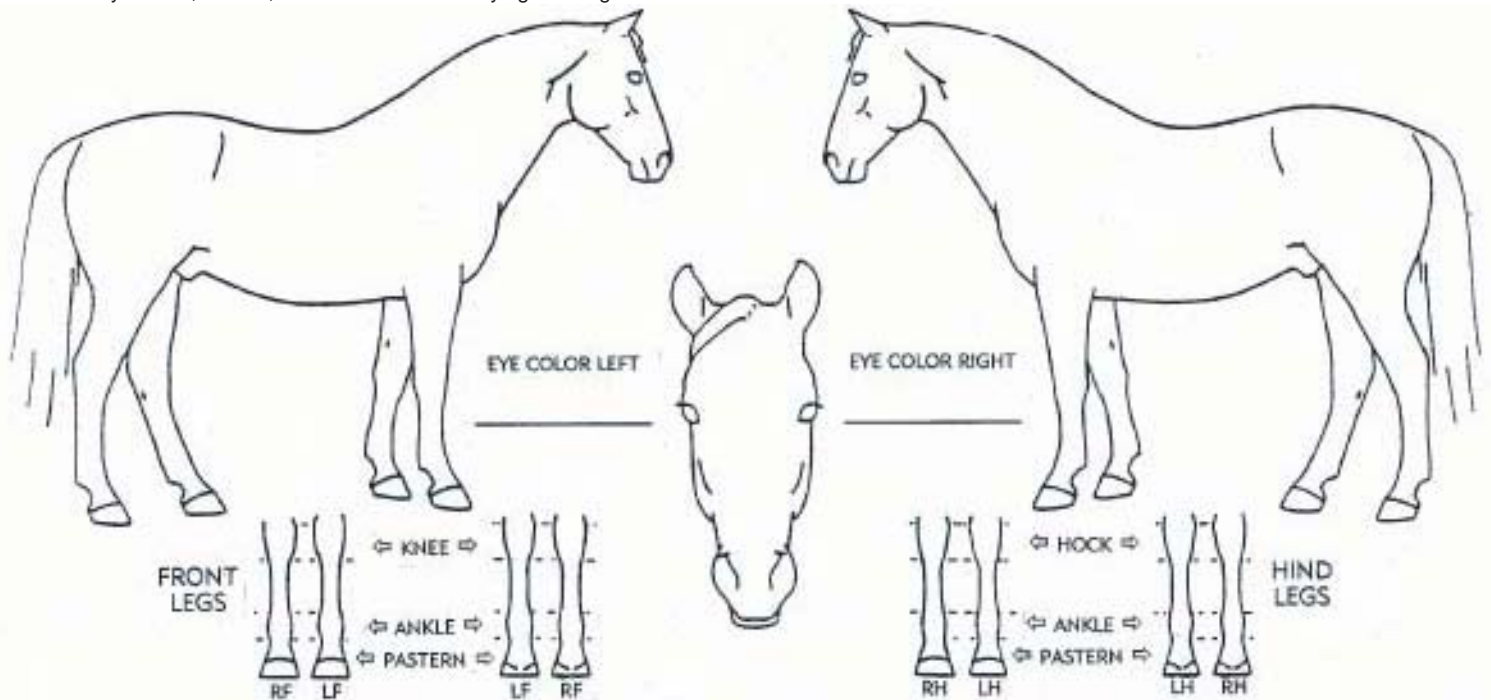

SECTION 2: SIRE INFORMATION (Stallion Service Certificate)

- Use full stallion and mare names including all numbers in the name.
- The USLR must have on file a STALLION REPORT from the owner/lessee of the above named stallion.
- All Lipizzan stallions and mares who sired foals in 1998 and thereafter must be DNA typed in order for their get to be registered. If there is a current blood sample on file with UC Davis, the cost is \$27 per horse to DNA type the parents. If for some unforeseen reason the sample has been destroyed, the cost is \$47 per horse. In some cases, DNA typing by another lab may be acceptable. If the parents are dead and have only been blood typed, then the horse being registered must be blood typed *and* DNA typed.
- Signatures of both stallion and mare owners/lessees should be acquired at the time of breeding.
- At the present time, imported horses are not required to have a STALLION REPORT or STALLION SERVICE CERTIFICATE filed with the Registration Application. A FULL Pedigree is required as outlined in the Rules and Regulations of the USLR.

DNA typing (as of 1/98) is required for REGISTERED Crossbreds (to be eligible for USDF awards) but is not required for RECORDED Crossbreds (pleasure horses).
